- (3) Mobile homes require prior coordination with Solid Waste Management Division.
- (4) As defined by Chapter 228 of the Code of Cecil County.
- (5) Minimum charge for scaled loads is \$10.00.
- (6) Maximum of 4 tires of any size per vehicle per day.
- (7) Requires possession of a valid Scrap Tire Hauler License issued by the Maryland Department of the Environment.
