

**COUNTY COUNCIL OF CECIL COUNTY

Mr. Sennstrom and Mr. Boothe provided information about Resolution No. 18-2015 Roads - Renaming - Eugene's Way, which will be introduced tonight.

Mr. Robinson presented Amendment No. 1 to Resolution No. 12-2015 Budget Amendment - Midyear Adjustment and provided explanation to the Council. Questions and discussion ensued. Resolution No. 12-2015 will be considered for approval at tonight's Legislative Session.

Council Manager Massey reminded Council Members that the following presentations are scheduled at the next work session on March 24: drug enforcement by Sheriff Adams, Eastern Shore Conservancy and Watershed Stewards Academy.

Councilwoman Bowsbey will be speaking to the Government Relations Committee next week. She attended the Planning Commission last night.


Councilman Schneckeburger welcomed the Lieutenant Governor and task force members to Cecil County.
