Approval of Minutes

On a motion made by Councilwoman Bowlsbey, seconded by Councilman Schneckenburger, the Council moved to approve the minutes of the Council work session of August 18, 2015. Motion was carried by a vote of 4 to 0. Vice President McCarthy was absent.

Citizens Corner Scheduling

The Council agreed by consensus to continue Citizens Corner at 6:00 P.M., prior to every legislative session beginning in September. They will reevaluate the schedule prior to next summer.

Discussion - Resolution No. 42-2015 Amendment - Policies and Procedures of the Cecil **County Council - Final Reading of Bills**

Council members discussed opposition to the proposed resolution. By consensus, the Council agreed to let Resolution No. 42-2015 die.

The Council Manager was asked to draft new legislation to propose that the legislative sponsor can request a bill or resolution to be "expedited". The sponsor must provide a reason that illustrates the benefit to the County. The Council must approve legislation for "expediting" by a supermajority or at least four votes at the time that the legislation is introduced. Expedited legislation will be considered for final reading at the same legislative session that the public hearing is concluded. A majority of Council Members may vote to delay an expedited bill for any reason.
