Synopsis: : A Resolution to amend the Annual Budget and Appropriation Ordinance for Cecil County, Maryland, for the fiscal year ending June 30, 2018, to increase the revenue estimate and budget expenditure authority within the General Fund Department of Parks and Recreation budget by \$20,000, in order to have sufficient budgetary authority to pay for necessary equipment for the wrestling and football programs.

Supplemental Appropriation – Parks and Recreation – Wrestling and Football Equipment

1 **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2017, the County
2 Executive submitted a proposed budget to the County Council for Fiscal Year 2018; and

3 **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council held public
4 hearings on the proposed budget submitted by the County Executive for Fiscal Year 2018; and

5 **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on June 15, 2017, the Budget
6 for Cecil County was adopted for Fiscal Year 2018; and

7 **WHEREAS**, the County Executive is increasing the FY2018 program revenue projection by \$20,000 to
8 capture the revenue earned above the FY2018 budget estimate for programs; and

9 **WHEREAS**, the County Executive is increasing the FY2018 expenditure budget by \$20,000 within the
10 Department of Parks and Recreation to purchase the needed equipment necessary for the paying participants
11 in the wrestling and football programs.

12 **NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND,**
13 that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for Fiscal Year 2018 is hereby
14 amended for the supplemental appropriation and by amending the Current Budget to increase the revenue
15 estimate and budget expenditure authority within the General Fund Department of Parks and Recreation by
16 \$20,000 to purchase the necessary equipment needed for the upcoming wrestling and football programs.

17 **AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND,** that this
18 Resolution shall take effect on the date of its passage by the County Council of Cecil County, Maryland.
