1 **WHEREAS**, Section 505 of the Charter of Cecil County requires the Executive to prepare a Proposed
2 Capital Improvement Program as part of the Budget Message to County Council for the ensuing fiscal year
3 not later than April 1 of each year; and

4 **WHEREAS**, the County Executive was not required to submit the Capital Improvement Program to
5 the Planning Commission for Fiscal Years 2019-2023 because the Capital Improvement Program contains no
6 new projects for FY 2019–2023; and

7 **WHEREAS**, all projects contained in the Capital Improvement Program for Fiscal Years 2019–2023
8 were recommended by the Planning Commission as part of the Capital Improvement Program for Fiscal
9 Years 2018-2022; and

10 **WHEREAS**, on March 30, 2018 the County Executive submitted the proposed capital
11 Improvement Program for Fiscal Years 2019–2023 to the County Council indicating the plan of the County
12 to receive and expend funds for capital projects, and providing for each capital project, the project
13 description, estimated costs and probable sources of funding; and

14 **WHEREAS**, the Cecil County Council has met all the requirements to consider the Capital
15 Improvement Program for Fiscal Years 2019–2023.

16 **NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**
17 **MARYLAND** that the Capital Improvement Program for the fiscal years ending June 30, 2019,
18 June 30, 2020, June 30, 2021, June 30, 2022, and June 30, 2023, attached as Appendix 1, is approved and
19 adopted.

20 **BE IT FURTHER ENACTED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND,** that that this
21 Bill shall take effect July 1, 2018.
