**Title of Resolution:** Budget Amendment – Grant Funds – Courthouse Facilities Maintenance Department - Courthouse LED Lighting

**Synopsis:** A Resolution to amend the Annual Budget and Appropriation Ordinance for Cecil County, Maryland, for the fiscal year ending June 30, 2019, in order to provide a total of \$75,170 to the Special Revenue Other Grants Fund-Courthouse Facilities Maintenance Department to record the incentive awarded from Delmarva Power for the purpose of retrofitting the Cecil County Courthouse with LED lighting.

Budget Amendment – Grant Funds – Courthouse Facilities Maintenance Department –  
Courthouse LED lighting

1       **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2018, the  
2 County Executive submitted a proposed budget to the County Council for Fiscal Year 2019; and

3       **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council  
4 held public hearings on the proposed budget submitted by the County Executive for Fiscal Year  
5 2019; and

6       **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on June 5, 2018,  
7 the Budget for Cecil County was adopted for Fiscal Year 2019; and

8       **WHEREAS**, the County Executive is revising the Fiscal Year 2019 Special Revenue Other  
9 Grants Fund revenue estimate for Cecil County to establish the following amount:

- 10       a)     The addition of \$75,170 in grant revenue and expense to the Special Revenue Other  
11             Grants Fund-Courthouse Facilities Maintenance operating budget from the Delmarva  
12             LED Incentive Program, and

13       **WHEREAS**, such appropriation is necessary to provide \$75,170 in grant expenditure to  
14 retrofit the Courthouse with LED lighting. The total cost of the project is \$126,571, leaving the  
15 County to pay \$51,400 of the total project cost.

16       **NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**  
17 **MARYLAND**, that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland, for  
18 Fiscal Year 2019 is hereby amended for the supplemental appropriation, and by amending the  
19 Current Budget to provide a total of \$75,170 to the Special Revenue Other Grants Fund-Courthouse  
20 Facilities Maintenance Department to record the incentive awarded from Delmarva Power for the  
21 purpose of retrofitting the Cecil County Courthouse with LED lighting.

22       **AND, BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND,**  
23 that this Resolution shall take effect on the date of its passage.
