Budget Appropriation – Capital Project – Board of Education – Cherry Hill Middle School

1 **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2018, the
2 County Executive submitted a proposed budget to the County Council for Fiscal Year 2019; and

3 **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council held
4 public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2019; and

5 **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on June 5, 2018, the
6 Budget for Cecil County was approved for Fiscal Year 2019; and

7 **WHEREAS**, the County Executive is revising the Fiscal Year 2019 Board of Education Capital
8 Projects Budget to add bond revenue and expense; and

9 **WHEREAS**, such appropriation of unencumbered bond revenue and expense totaling \$290,000 is
10 requested to be added to the Cherry Hill Middle School Window and Doors Replacement Project:

- 11 a) The project was added to the FY2019 Capital Improvement Program with the intention of
12 being funded by both the State and the County in FY2020.
- 13 b) In May 2018 the state awarded their share of the funding (\$564,000) in the FY2019 Capital
14 Project cycle.
- 15 c) The County’s proposed Capital Improvement Program had already been introduced to Council
16 and therefore unable to be altered by the Executive.
- 17 d) The Board of Education is requesting the County’s share of the funding be pulled forward to
18 FY2019 in order to accommodate for a Spring 2019 construction schedule.

19 **NOW THEREFORE, BE IT HEREBY ENACTED BY THE COUNTY COUNCIL OF CECIL COUNTY,**
20 **MARYLAND**, that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for Fiscal
21 Year 2019 is hereby amended for the supplemental appropriation and by amending the Budget to
22 appropriate additional bond appropriation authority within the Board of Education Capital Projects
23 Budget in the amount of \$290,000 in order to provide the necessary County share to replace the windows
24 and doors at Cherry Hill Middle School.

25 **AND, BE IT FURTHER ENACTED** that this Act shall take effect in 60 calendar days from the date it
26 becomes law.
