1           **WHEREAS**, pursuant to the Code of Cecil County, Maryland, Section 142, Article II, §142-2A(1), the  
2 Animal Care and Control Advisory Board, ACCAB, shall consist of an individual citizen recommended by  
3 the County Council and appointed by the County Executive; and an individual citizen recommended and  
4 appointed by the County Executive; and the Cecil County Sheriff or designee, Chief Health Officer or  
5 designee, and Director of Finance or designee; and

6           **WHEREAS**, the individual citizen to be appointed to the ACCAB shall have no actual or perceived  
7 conflict of interest pursuant to the ethics provisions established by Chapter 39 of the Code of Cecil  
8 County, Maryland; and

9           **WHEREAS**, the powers and duties of the ACCAB are to work with the County's Animal Care and  
10 Control Authority, ACCA; to review current animal laws and recommend changes; to review the  
11 performance of ACCA; to review annually and make recommendations of any changes in the ACCA  
12 contract; and to serve as a review board for cases involving public or interagency complaints regarding the  
13 ACCA, and

14           **WHEREAS**, Article 4, Section 412 (b) of the Charter of Cecil County provides that the County  
15 Executive shall appoint all members of boards and commissions, subject to confirmation by the Council;  
16 and

17           **WHEREAS**, the County Executive has recommended and reappointed S. Lee Lewis to the ACCAB,  
18 for a two year term to expire on March 1, 2018; and

19           **WHEREAS**, the County Council has recommended and the County Executive has appointed Arnold  
20 Fox, for a two year term to expire on March 1, 2018.

21           **NOW, THEREFORE, BE IT HEREBY RESOLVED** that the County Council of Cecil County confirms the  
22 appointments of S. Lee Lewis and Arnold Fox to the Cecil County Animal Care and Control Advisory Board  
23 for a two year term to expire on March 1, 2018.
