1 **WHEREAS**, pursuant to Tax Property Article of the Annotated Code of Maryland, Title 3, Section 3-102
2 there is a property tax assessment appeal board in each county; and

3 **WHEREAS**, pursuant to Tax Property Article, Title 3; Section 3-103(a), the Property Tax Assessment
4 Appeal Board is comprised of three members and one alternate member, who are appointed by the Governor,
5 and

6 **WHEREAS**, pursuant to Section 3-103(a) of the Tax Property Article, the Governor appoints the
7 members from a list of names, as submitted by the County Executive with the approval of the County Council;
8 and

9 **WHEREAS**, pursuant to Section 3-103(c)(2) of the Tax Property Article, the term of a member is five
10 years and ends on June 1, 2021 of the appropriate year, but a member continues to serve until a successor is
11 appointed and qualifies; and

12 **NOW, THEREFORE, BE IT RESOLVED** by the County Council of Cecil County, Maryland, that the County
13 Executive and County Council approve the following list of names to be submitted to the Governor for
14 appointment to the current vacant seat on the Cecil County Property Tax Assessment Appeal Board: Steven F.
15 Pearson, Frank Muller and Suzan Doordan.

16 **AND, BE IT FURTHER RESOLVED** that this Resolution shall take effect on the date of its passage by the
17 County Council of Cecil County, Maryland.
