1 **WHEREAS**, Pursuant to Section 39.2 (C) of the Code of Cecil County, the County enacted the Cecil
2 County Public Ethics Laws to guard against improper influence and to require County elected officials,
3 officials, employees, and individuals appointed to boards and commissions to disclose their financial affairs
4 and to set minimum standards for the conduct of local government business;

5 **WHEREAS**, Pursuant to Section 39.4(A) of the Code of Cecil County, the Cecil County Ethics
6 Commission shall be composed of five members with staggered four year terms;

7 **WHEREAS**, Pursuant to Section 39.4(C) of the Code of Cecil County, no more than three members of
8 the Commission shall be affiliated with the same political party;

9 **WHEREAS**, The Ethics Commission is comprised of three members who are affiliated with the
10 Republican Party and one member who is affiliated with the Democratic Party;

11 **WHEREAS**, Pursuant to Section 412(b) of the Charter of Cecil County, the Executive shall appoint all
12 members of boards and commissions and that such membership shall be subject to confirmation by the
13 Council;

14 **WHEREAS**, The County Executive approves the appointment of Donna Caudell, who is registered
15 Republican, for a four year term to expire in December 2020.

16 **NOW, THEREFORE, BE IT HEREBY RESOLVED** that the County Council of Cecil County confirms the
17 appointment Donna Caudell to the Cecil County Ethics Commission for a four year term to expire in
18 December 2020; and

19 **BE IT FURTHER RESOLVED** by the County Council of Cecil County that all provisions of Resolution -
20 2014 shall take effect on the date the Resolution is adopted by the Council.
