The applicants were duly sworn by the Clerk; Mr. Wilson read the legal notice which appeared on dates of September 10 and 17, 2014. The fully executed application packet with proper fees included: signatures of 10 registered voters and property owners in District 6; the certification form stated "Restaurant/Bar will be serving food and alcohol." Chairman Snelling asked about the significant improvements to the structure; Mr. Hanks stated they are ongoing. Chairman Snelling asked about live music; Mr. Hanks stated one night a week. Mr. Hanks stated they will serve steak, seafood, crabs. Commissioner Eller asked about off premises sales; Mr. Hanks stated they have no desire for this. Chairman Snelling asked about outdoor seating and music; Mr. Hanks stated there will be an area used for smoking, but they will not have outdoor service at this time. Chairman Snelling reminded the applicants that if in the future they wish to have outdoor service, they will need to come in and request this. With no further questions, Commissioner Eller made a motion to approve the new Class "B" BWL license with the condition of submitting a copy of the occupancy permit; Commissioner Curry seconded that motion and the Board unanimously voted to approve the license as stated.
