Information and Policies of Cecil Travelers

Service: Trips are arranged by the volunteer services of Anne Williams-Kirk, Lois Sutherland and Arlene Zappo. Trips are offered to all Cecil County seniors. Contract payments to coach and tour companies are from travelers only. Tours are not subsidized by any other funding. Volunteer arrangers are responsible for all payments. We try to offer the best tours at the lowest cost possible. In order to do so we must enforce the payment and cancellation policy.

Reservations:

1. To reserve a seat, call **Lois at 410-287-5916** between the hours of 8 am to 8 pm. Caller's name is placed on the 'interested list' for 7 business days.
2. A deposit or full payment should be received within the 7 business days to guarantee reservations.
3. **NOTICE:** Sorry, time **DOES NOT** permit payment reminder calls. After the 7 business day period the reservation will become available to other callers.

Cancellation Policy: Refunds will be made only if YOU personally find someone to replace you on the trip. Escorts will assist only if there is a waiting list. After contracts are signed by the volunteers and the tour companies, the responsibility is strictly that of the volunteer.

Boarding the Coach: Boarding is at the **VILLAGE OF ELKTON** unless otherwise listed. Seating is arranged according to Travelers and Companion's FINAL PAYMENTS. Boarding and seating will begin 15 minutes prior to departure time. The traveler and companion names will be called by escort. Overnight travel seating is assigned in advance according to final payment date. We DO NOT participate in rotation of seats. At times, there are seats reserved for our clients who will be picked up at the American Legion in Rising Sun or the Perryville Park N Ride. Please do not move these reserved seat signs.
