1 **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2015, the County
2 Executive submitted a proposed budget to the County Council for Fiscal Year 2016; and

3 **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council held
4 public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2016; and

5 **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on June 2, 2015, the
6 County Council adopted the budget for Fiscal Year 2016; and

7 **WHEREAS**, the County Executive is revising the Fiscal Year 2016 revenue estimate for Cecil County to
8 increase use of Fund Balance available by \$325,000 to allow the following appropriation within the General
9 Fund:

- 10 a) The addition of \$325,000 (\$250,000 snow removal, \$50,000 overtime, \$25,000 Motor Vehicle)
11 in expenditures for the Road's Maintenance snow removal budget to protect County citizens
12 traveling County maintained roads.

13 **WHEREAS**, such appropriation is necessary to provide \$325,000 of fund balance for the General
14 Fund for expenditures.

15 **NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**
16 **MARYLAND**, that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for Fiscal
17 Year 2016 is hereby amended for the supplemental appropriation and by amending the Current Budget to
18 appropriate \$325,000 of additional expenditures in the General Fund to the Road's Maintenance
19 Department's budget.

20 **AND BE IT FURTHER RESOLVED** that this Resolution shall take effect on the date of its passage by
21 the County Council of Cecil County, Maryland.
