1           **WHEREAS**, pursuant to Tax Property Article of the Annotated Code of Maryland, Title 3, Section 3-102  
2 there is a property tax assessment appeal board in each county; and

3           **WHEREAS**, pursuant to Tax Property Article, Title 3; Section 3-103(a), the Property Tax Assessment  
4 Appeal Board is comprised of three members and one alternate member, who are appointed by the Governor,  
5 and

6           **WHEREAS**, pursuant to Section 3-103(a) of the Tax Property Article, the Governor appoints the  
7 members from a list of names, as submitted by the County Executive with the approval of the County Council;  
8 and

9           **WHEREAS**, pursuant to Section 3-103(c)(2) of the Tax Property Article, the term of a member is five  
0 years and ends on June 1, 2021 of the appropriate year, but a member continues to serve until a successor is  
1 appointed and qualifies; and

2           **NOW, THEREFORE, BE IT RESOLVED** by the County Council of Cecil County, Maryland, that the County  
3 Executive and County Council approve the following list of names to be submitted to the Governor for  
4 appointment to the current vacant seat on the Cecil County Property Tax Assessment Appeal Board: Steven F.  
5 Pearson, Frank Muller and Suzan Doordan.

6           **AND, BE IT FURTHER RESOLVED** that this Resolution shall take effect on the date of its passage by the  
7 County Council of Cecil County, Maryland.
