**Title of Bill:** Budget Ordinance FY2014 – Appropriations – General Fund – Grant Revenue Sheriff’s Office

**Synopsis:** An act to amend the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for FY2014 in order to provide \$60,000 in additions to the General Fund Grants Budget for the Sheriff’s Office to provide additional appropriation authority for the fiscal year ending June 30, 2014.

1           **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on March 1, 2013, the  
2 County Executive submitted a proposed budget to the County Council for Fiscal Year 2014; and,

3           **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council held  
4 public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2014; and,

5           **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on May 21, 2013, the  
6 County Council adopted the budget for Fiscal Year 2014; and,

7           **WHEREAS**, the County Executive is revising the Fiscal Year 2014 Grant Budget revenue estimate  
8 for Cecil County to establish the following amounts within the General Fund pursuant to an award  
9 notification; and are as follows:

- 10           a) The addition of \$60,000 grant revenue and expense to the Sheriff’s Office budget for a Crime  
11 Analyst position awarded by the Maryland State Police and the Governor’s Office of Crime  
12 Control and Prevention; and,

13           **WHEREAS**, such appropriation is necessary to provide \$60,000 grant funding for the General  
14 Fund expenditures; and

15           **WHEREAS**, Section 506 of the Charter of Cecil County requires that no final budget action may be  
16 taken by the County Council until after public hearing or hearings have been held in open public session;  
17 and,

18           **WHEREAS**, County Council has caused notice of a public budget hearing on the recommended  
19 appropriation to be published in a newspaper of general circulation in Cecil County.

21           **NOW THEREFORE,**

22 Section 1. Be It Hereby Enacted by the County Council of Cecil County, Maryland that the Annual Budget  
23 and Appropriation Ordinance for Cecil County, Maryland for Fiscal Year 2014 is hereby amended for the  
24 supplemental appropriation and by amending the Current Expense Budget to appropriate additional  
25 expenditures in the General Fund to increase the General Fund by the amount of \$60,000; and

26 Section 2. And Be it Further Enacted that this Act shall take effect on \_\_\_\_\_ when it  
27 becomes law.
