1           **WHEREAS**, it is the policy of the State that adults who lack the physical or mental capacity to care  
2 for their basic daily living needs shall have access to and be provided with needed professional services to  
3 protect their health, safety and welfare; pursuant to Section 14-102 (Legislative policy and intent) of the  
4 Maryland Annotated Code, Family Law Article, Title 14 (Adult Protective Services); and

5           **WHEREAS**, the Maryland Secretary of Human Resources shall develop, supervise, and cause each  
6 local department to implement a program of protective services for vulnerable adults, pursuant to Section  
7 14-201 of the Family Law Article of the Maryland Annotated Code; and

8           **WHEREAS**, there shall be at least one review board established in each county; pursuant to  
9 Section 14-401(a) of the Family Law Article of the Maryland Annotated Code; and

10           **WHEREAS**, the review board shall review each guardianship that a public agency holds at least  
11 once a year and shall conduct a file review at least every six months, pursuant to Section 14-404 of the  
12 Family Law Article of the Maryland Annotated Code; and

13           **WHEREAS**, the Cecil County Adult Public Guardianship Review Board is an interdisciplinary team  
14 that acts as a consultant to the public guardians, reviewing public guardianship cases every six months  
15 and making recommendations to the court to continue, modify, or terminate guardianship of the person;  
16 and

17           **WHEREAS**, Article 4, Section 412 (b) of the Charter of Cecil County provides that the County  
18 Executive shall appoint all members of boards and commissions, subject to confirmation by the Council;  
19 and

20           **WHEREAS**, the County Executive has recommended Shana Proctor, Stevens Remillard, Beth  
21 Remillard, Dianne Fox and Linda Willis for reappointment to the Adult Public Guardianship Review Board  
22 and appointment of Randall Schwandt to the Adult Public Guardianship Review Board to a three year  
23 term, which is to expire on November 5, 2022.

24           **NOW, THEREFORE, BE IT HEREBY RESOLVED THAT THE COUNTY COUNCIL OF CECIL COUNTY,**  
25 **MARYLAND**, confirms the recommendation by the County Executive of Shana Proctor, Stevens Remillard,  
26 Beth Remillard, Dianne Fox and Linda Willis to the Adult Public Guardianship Review Board and  
27 appointment of Randall Schwandt to the Adult Public Guardianship Review Board, to a three year term,  
28 which is to expire on November 5, 2022.

29 **AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND,** that this  
30 Resolution shall take effect on the date of its passage.
