1           **WHEREAS**, Pursuant to Maryland Annotated Code, Agriculture Article, Section 9-2402(4), the  
2 Secretary of Agriculture may enter into agreements with any county or subdivision of the State to effect a  
3 program of control and eradication of noxious weeds; and

4           **WHEREAS**, Pursuant to a Memorandum of Understanding between the Maryland Department of  
5 Agriculture and Cecil County, which was approved by the Cecil County Board of Commissioners on March  
6 16, 2010, the Cecil County Board of County Commissioners agreed to appoint a Weed Advisory  
7 Committee to assist the Department of Agriculture in developing and implementing a Noxious Weed  
8 Control Program; and

9           **WHEREAS**, the Weed Advisory Committee of Cecil County works with the Roads Division of the  
10 Department of Public Works in providing oversight for the weed control program, and

11           **WHEREAS**, Article 4, Section 412 (b) of the Charter of Cecil County provides that the County  
12 Executive shall appoint all members of boards and commissions, subject to confirmation by the Council;  
13 and

14           **WHEREAS**, the County Executive has recommended Monty D. Johnson, II, Jim Calao, William  
15 Ewing, C. Michael Scheeler, Dan Webber, Lane Heimer, Ronald Penhollow for reappointment and has  
16 recommended Mark T. Martin for appointment to the Weed Control Advisory Board for a one (1) year  
17 term, to expire March 15, 2021.

18           **NOW, THEREFORE, BE IT HEREBY RESOLVED THAT THE COUNTY COUNCIL OF CECIL COUNTY,**  
19 **MARYLAND**, confirms the recommendation by the County Executive of Monty D. Johnson, II, Jim Calao,  
20 William Ewing, C. Michael Scheeler, Dan Webber, Lane Heimer, Ronald Penhollow for reappointment and  
21 has recommended Mark T. Martin for appointment to the Weed Control Advisory Board for a one (1) year  
22 term, to expire March 15, 2021.
