1 **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2020, the County
2 Executive submitted a proposed budget to the County Council for Fiscal Year 2021; and

3 **WHEREAS**, *Md. Code Ann., § 9-303, Tax-Property Article* permits the governing body of Cecil County
4 to grant a property tax credit against the County property tax imposed on property that is owned by a little
5 league in Cecil County, Maryland; and

6 **WHEREAS**, on June 20, 2006, the Board of County Commissioners for Cecil County, acting pursuant
7 to the authority provided under *Md. Code Ann., § 9-303, Tax-Property Article*, passed a Resolution granting:
8 (1) a tax credit imposed on the property of the North East Little League, designated as Parcel 786 on Tax
9 Map 600 and Parcel 1105 on Tax Map 31; and, (2) a tax credit imposed on the property of the American
10 Legion, Inc., Mason-Dixon Post 194, designated as Parcel 367 on Tax Map 600 and Parcel 291 on Tax Map
11 600 for use by the Rising Sun Little League; and

12 **WHEREAS**, the Rising Sun Little League has now acquired two (2) additional parcels of real property,
13 which are designated as Parcel 365 on Tax Map 600 and Parcel 369 on Tax Map 600; and,

14 **WHEREAS**, the Rising Sun Little League has now requested property tax credits against Parcels 365
15 and 369 pursuant to *Md. Code Ann., § 9-303, Tax-Property Article*.


16 **NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**
17 **MARYLAND**, that in accordance with *Md. Code Ann., § 9-303, Tax-Property Article*, a tax credit is imposed
18 on the property of the Rising Sun Little League, designated as Parcel 365 on Tax Map 600 and Parcel 369 on
19 Tax Map 600.

20 **AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND**, that this
21 Resolution is effective retroactive to July 1, 2019.

22 **AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND**, that all
23 provisions of this Resolution shall take effect on the date that it is approved.
