Supplemental Appropriation – Grant Funds – Parks and Recreation – County Parks Cleanup

1 **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2019, the County
2 Executive submitted a proposed budget to the County Council for Fiscal Year 2020; and

3 **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council held
4 public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2020; and

5 **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on June 4, 2019, the
6 Budget for Cecil County was adopted for Fiscal Year 2020; and

7 **WHEREAS**, the County Executive is revising the Fiscal Year 2020 Special Revenue Other Grants Fund
8 – Parks and Recreation Department revenue estimate for Cecil County to establish the following amount:

9 the addition of \$5,000 in grant revenue and expense to the Special Revenue Other Grants Fund –
10 Parks and Recreation grants operating budget to provide for community cleanup at County parks; and

11 **WHEREAS**, such appropriation is necessary to provide \$5,000 in funding to be used to purchase
12 necessary supplies for the community cleanup at Calvert Park and Brantwood Park.

13 **NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**
14 **MARYLAND**, that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for Fiscal
15 Year 2020 is hereby amended for the supplemental appropriation and by amending the Current Budget to
16 appropriate \$5,000 in additional expenditures in the Special Revenue Other Grants Fund – Parks and
17 Recreation Department to record the grant from the Maryland Department of Housing and Community
18 Development, the Forever Maryland Foundation, and the Maryland Environmental Trust for the purpose of
19 community cleanup efforts at County parks.

20 **AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND**, that this
21 Resolution shall take effect on the date of its passage.

SUMMARY OF LEGISLATION

SPONSOR: Council President at the request of the County Executive

RESOLUTION NO. 27-2020 – Supplemental Appropriation – Grant Funds – Parks and Recreation – County Parks Community Cleanup

SYNOPSIS: A Resolution to amend the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for the fiscal year ending June 30, 2020 in order to provide a total of \$5,000 to the Special Revenue Other Grants Fund-Parks and Recreation Department to record the grant from the Maryland Department of Housing and Community Development, the Forever Maryland Foundation and the Maryland Environmental Trust for the purpose of community cleanup efforts at County parks.

FISCAL IMPACT SUMMARY: Net fiscal impact to the County will be zero for Fiscal 2020. The grant funding will pay for the expenses incurred on the day of the cleanup event.

FISCAL ANALYSIS:

A grant was awarded to the Cecil County Department of Parks and Recreation to conduct a community event to cleanup at Calvert Regional Park and Brantwood Park. Due to the pandemic crisis, the date for the event has not been set. The grant dollars will be made available to purchase supplies for the event.
