1           **WHEREAS**, the County Executive submitted a proposed budget to the County Council for  
2 Fiscal Year 2021; and

3           **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council  
4 held public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2021;  
5 and

6           **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, the County Council  
7 adopted the budget for Fiscal Year 2021 on May 19, 2020; and

8           **WHEREAS**, the State of Maryland through the Department of Housing and Community  
9 Development has solicited applications from eligible jurisdictions to apply for funding under the  
10 Maryland Community Development Block Grant Program, for funds awarded through the Federal  
11 CARES Act; and

12           **WHEREAS**, Cecil County is eligible to apply for funds from the Maryland Community  
13 Development Block Grant COVID-19 Response program through the Maryland Department of  
14 Housing and Community Development; and

15           **WHEREAS**, the Department of Community Services, representing Cecil County, MD has been  
16 authorized to apply for grant funds up to \$496,000, designated for the prevention, preparation for  
17 and response to the Coronavirus Pandemic in Cecil County, Maryland; and

18           **WHEREAS**, the Department of Community Services, through its Housing and Community  
19 Development Division and in collaboration with community partners, is applying for funding  
20 that will be used for staff support and to administer rental assistance services due to  
21 COVID-19; and

22           **WHEREAS**, the County has scheduled a required virtual public hearing, related to the  
23 formulation of the County’s Block Grant Application, on Wednesday, September 23, 2020 at  
24 2:00pm, and which public legal notice will be given; and

25           **WHEREAS**, the Cecil County Council understands and acknowledges that the County would  
26 be responsible for completion of grant activities and any corrective actions, including the  
27 repayment of funds, if necessary.

28           **NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**  
29 **MARYLAND**, that the County Executive is authorized, by and through the Cecil County Department  
30 of Community Services, to submit an application for Community Development Block Grant Program-

31 COVID Funding.

32 **AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND,** that  
33 the County Executive or his designee is authorized and empowered to execute any and all  
34 documents required for the submission of the application.

35 **AND, BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND,**  
36 that this Resolution shall take effect on the date of its passage.
