Amendment-Policies and Procedures of Cecil County Council-Format Legislative Session Agenda

1 **WHEREAS**, pursuant to Section 202 of the Charter of Cecil County, Maryland (the "Charter"),
2 the County Council of Cecil County, Maryland (the "Council") is the Legislative Branch of government;
3 and

4 **WHEREAS**, the legislative powers and procedures are outlined in the Charter; and

5 **WHEREAS**, pursuant to Section 303(e) of the Charter, the Council may adopt and publish
6 additional rules of legislative procedure that may be desirable and not in conflict with the Charter;
7 and

8 **WHEREAS**, the Council has determined that additional policies and procedures are
9 necessary to support the legislative process in order to operate in a consistent and efficient
10 manner; and

11 **WHEREAS**, the policies and procedures of the Council may be amended by the Council
12 according to the legislative procedures in Sections 303-304 of the Charter.


13 **NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**
